## Notes from the Branch Vice-President

Hello out there.

Well, another meeting has come and gone, which means it is time for another message from yours truly. As both time and creativity seem to be lacking on my part, I will keep this passage short.

Last month I talked about training programs for hydrographers and the conspicuous lack thereof, in Canada. While not meaning to beat a dead horse a few more inches into the grave, that idea was brought back to the forefront for me, as I browsed the March/April 2003 edition of *Engineering Dimensions* - a publication of the Professional Engineers of Ontario (PEO). The magazine is dominated by the overtone of attaining, maintaining, and proving one's professional competence, as well as policing and enforcement to protect the public against incompetence.

As I read, it reinforced to me the idea that if hydrography is going to continue to be a viable profession in Canada, we in the industry have to take this matter seriously. Every day experience and knowledge is being lost to attrition, and unless a training regime and a comprehensive set of professional standards are set in place, that knowledge base will not be adequately replaced.

Having said that, I am pleased that the CHA is still playing a role in education. The multibeam course hosted by the CHA in Burlington last year was very well received, and the Side Scan Sonar Course scheduled for the end of this month filled up quickly, and promises to be a high-quality program. Further, the Ottawa Branch is a prominent partner in the 2004 Hydrographic Conference in Ottawa, and the CHA will continue to support these important events. While these efforts are encouraging, much more needs to be done.

On a final and way more upbeat note, it gives me great pleasure to announce the recent marriage of Central Branch member Dan Dexel. I'm sure that you will join me in extending congratulations and best wishes to Dan and Heather.
